NOTICE

REAPPOINTMENT OF INCUMBENT MAGISTRATE

The current term of the office of United States Magistrate Harry W. McKee is due to expire on August 5, 1990. The United States District Court is required by law to establish a panel of citizens to consider the reappointment of the magistrate to a new eight-year term.

The duties of the magistrate position include the following:

- (1) all powers and duties conferred or imposed upon United States commissioners by law or by the Rules of Criminal Procedure for the United States District Courts; and
- (2) the power to administer oaths and affirmations, issue orders pursuant to Section 3142 of Title 18 concerning release or detention of persons pending trial, and take acknowledgements, affidavits and depositions; and
- (3) the power to conduct trials under Section 3401, Title 18, United States Code, in conformity with and subject to the limitations of that section; and
- (4) a judge may designate a magistrate to hear and determine any pretrial matter pending before the court, except a motion for injunctive relief, for judgment on the pleadings, for summary judgment, to dismiss or quash an indictment or information made by the defendant, to suppress evidence in a criminal case, to dismiss or to permit maintenance of a class action, to dismiss for failure to state a claim upon which relief can be granted, and to involuntarily dismiss an action. A judge of the court may consider any pretrial matter under this subparagraph where it has been shown that the magistrate's order is clearly erroneous or contrary to law;
- (5) a judge may also designate a magistrate to conduct hearings, including evidentiary hearings, and to submit to a judge of the court proposed findings of fact and

recommendations for the disposition, by a judge of the court, of any motion excepted in subparagraph (4) above, of applications for post-trial relief made by individuals convicted of criminal offenses and of prisoner petitions challenging conditions of confinement; and

- (6) the magistrate shall file his proposed findings and recommendations under subparagraph (5) above, with the court and a copy shall forthwith be mailed to all parties; and
- (7) a judge may designate a magistrate to serve as a special master pursuant to the applicable provisions of this title and the Federal Rules of Civil Procedure for the United States District Courts. A judge may designate a magistrate to serve as a special master in any civil case, upon consent of the parties, without regard to the provisions of Rule 53(b) of the Federal Rules of Civil Procedure for the United States District Courts; and
- (8) a magistrate may be assigned such additional duties as are not inconsistent with the Constitution and laws of the United States.

A United States Magistrate must be competent to perform the duties of the office, of good moral character, emotionally stable and mature, committed to equal justice under the law, in good health, patient, courteous, and capable of deliberation and decisiveness when required to act on their own reason and judgment.



A full public notice for the magistrate position is posted in the office of the clerk of the district court at Tyler, Texas.


