MOTIONS TO QUASH SERVICE AND TO DISMISS FOR LACK OF IN PERSONAM
JURISDICTION, IN ASBESTOS CASES

IT IS ORDERED that motions to quash service of process, and motions to dismiss for lack of in personam jurisdiction, presented for filing in asbestos cases in this district, shall be considered "standard motions," and any objections or responses thereto shall be considered "standard objections or responses," and, as such, they shall be filed once only, to the Master Asbestos File, Master Docket 1:90mc1000. They shall not be presented for filing in individual cases.

IT IS FURTHER ORDERED that said motions are DENIED. All such motions and objections or responses thereto previously filed and pending disposition at this time are DENIED.

In the event an appeal is taken, the afore-mentioned motions shall be filed with or after the filing of the notice of appeal, by any party desiring to preserve the record for appeal, but no later than twenty (20) days after the notice of appeal is filed. Responses to the motions must be filed no later than ten (10) days thereafter.
