ORDER AMENDING THE PLAN FOR RANDOM SELECTION OF JURORS

It is hereby ORDERED that the Plan for Random Selection of Jurors for the Eastern District of Texas of July 1, 1985, be and the same is hereby amended, subject to approval by a reviewing panel of members of the Fifth Judicial Circuit Council:

Section 6. Master Jury Wheels

The first sentence is amended to:

The clerk or any other person authorized by the court shall establish and maintain, one Master Jury Wheel for each Division as described below.

Section 8. Qualification for Service

c. Excuses from Jury Service

An additional ground for excuse upon individual request is added as follows:

- (6) A person who serves as a volunteer (without compensation) in an official capacity as a firefighter or a member of a rescue squad or ambulance crew for a public agency.

A "public agency" for this purpose means the United States, any State of the United States, the District of Columbia, Puerto Rico, the Virgin Islands, Guam,

American Samoa, or other territory of the United States, or any unit of local government, department, or

instrumentality of any of the foregoing.


d. Individual Excuse from Jury Service


The first paragraph is amended as follows:




