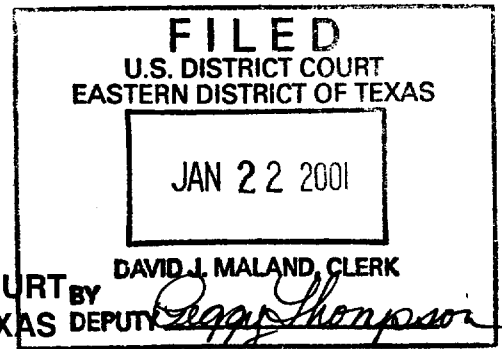


General Order No. 01-1
