GENERAL ORDER APPOINTING CJA PANEL MEMBERS

Upon recommendation of the CJA Panel Selection Committee and approval by the judges of this court, it is hereby ORDERED that the individuals listed in the attachment are appointed as members of this court's CJA panels. Each panel member's appointment shall continue until further order of the Court.

It is further ORDERED that Judge Judith K. Guthrie is appointed to the CJA Panel Selection Committee to replace Judge Harry W. McKee upon his retirement. Judge Keith Giblin also is appointed to replace Judge Earl Hines on the Committee.
